**CHAIR - Kelly:** Members of the convention committee who were involved in a recent investigation of misconduct have been reinstated, as it did not meet the criteria for misconduct as stated in the guidelines.

**VICE CHAIR - Mike:** Guidelines are being reviewed, and will be voted on next month.

**SECRETARY - Luna:** Southern Antelope Valley got their vote back.

**RD - Jade:** Strategic planning meeting was held and the Pamphlet Mock -up is in the google group (2 drafts.) May 1st is Service Day! NA World Services will be hosting an open webinar on Revitalizing and Reimagining Service Committees on Saturday, May 3rd. We will hear from trusted servants around the world who have been innovating new ways to deliver services. Addicts are brilliant, creative, and resourceful people, and when we put that imaginative power to work carrying the NA message, the results are amazing! WCNA Shop – NAWS is telling us that this is the very last chance for WCNA merchandise. The WCNA shop is closing its virtual doors for the last time on May 7th. There is liquidation pricing, cool stuff, and this is the last chance. CAR Survey input form – Do you have a great idea that the Fellowship should consider? NA members have been proposing ideas through the CAR survey for almost a decade. The CAR survey input form is posted until May 20th. Filling it out will carry your idea to conference participants who will work together to shape that survey. CAR Motions – The deadline for regions and zones to submit motions for the Conference Agenda Report is July 1, 2025. Those motions must be “CAR ready” by August 3, 2025. Arizona Region’s Motion Last month, we asked all of the RCMs to go back to their areas and ask the groups to decide if we should become a co-maker of that motion. Because of the July 1st deadline for submitting CAR motions, we need to vote at the RSC in June as to whether we, as a region, wish to become a co-sponsor of this motion. The Motion from the Arizona Region is: IDEA and REQUEST: To submit a motion at the World Service Conference to create a project plan to explore responsible ways to make book length pieces of electronic literature available on tablets for the incarcerated population. Intent: To explore new ways to effectively carry the message through electronic literature to the incarcerated population while protecting the integrity of our literature through the FIPT.

**PHONE LINES - Carlos:** Incoming calls were being miscalculated. Here is the breakdown since January 2025 monthly bill. Please keep in mind that all missed calls were returned, and this calculation is based on the actual monthly phone bill. December 13 to January 12 > 507 incoming calls, 22 missed calls. January 13 to February 12 > 507 incoming calls, 20 missed calls. February 13 to March 12 > 503 incoming calls, 16 missed calls. March 13 to April 12 > 515 incoming calls, 20 missed calls.

**CONVENTION - Frank:** SCRCNA 46 SoCal Clean "The Atmosphere of Recovery" is coming up on Aug 22-24 @ Anaheim Marriott. The speaker jam will kick off Aug 21st. Pre Reg is \$40 and onsite registration is \$50.00. Banquet tickets are \$70.00. If you pre register and purchase a banquet ticket in a bundle you will save \$10.00. Hotel reservations and rates are on the website.

Convention is asking areas for donations for bingo.

**PUBLIC RELATIONS - Stephen:** Open positions in the Committee are Area Relations Coordinator, Community Relations Coordinator, PSA and Alternate PSA Coordinators. Suggested requirements are available upon request. They are still waiting to hear how many Areas may participate in the Grocery Receipt project. They will be an exhibitor at the Evolution of Psychotherapy Conference in December 2025. The exhibitor fee has been discounted to \$1,650 from \$4,000 as a 12-Step Fellowship. This is a four-day national conference for professionals in the mental health and behavioral health fields. We are seeking participation from the OC and South Coast Areas. They will also be exhibiting at the Long Beach Marathon in October 2025 along with the Bay Cities Area. A discount code for the non-profit discount of 30% has been created for them, reducing the cost for the Region to \$525. Additionally, they have been given the opportunity to exhibit at the KJLH Radio Station Women's Health Expo on May 31, 2025, at the Long Beach Convention Center. It marks the 25th anniversary of this event, and a large attendance is anticipated. The cost was reduced from \$1,500 to \$1,000 for our non-profit organization. The Regional contribution will be \$400, with Bay Cities and Greater LA contributing a combined \$600. Service Works will be held virtually on Saturday, June 7, from 11:00am to approximately 1:30pm, depending on the length of the presentations. Our Regional Delegate Team has been invited to discuss our Regional Service Development project. The December Service Works event is scheduled for Saturday, December 6, 2025. We are

considering hosting the event later in the day, followed by another event. Further details will be provided. In March 2025, total attendance at the SoCal Region Parolee Meetings reached 727. RCMs to please announce that they host two presentations/meetings exclusively for parolees on Tuesday mornings at 10am and Thursday evenings at 7pm on Zoom. They are also recruiting Trusted Servants for both meetings. They are currently developing Guidelines for posting social media PSAs.
